

## Position Announcement Aesthetics Technology Instructor

The Tennessee College of Applied Technology Hohenwald is accepting applications for a full-time Aesthetics Technology Instructor.

## **Minimum Requirements**

- A high school diploma or GED required; Associate Degree preferred.
- Vocational or Technical School certification training or apprenticeship in Aesthetics required.
- Active Tennessee License as Aesthetics and/or Cosmetology Instructor required.
- Three (3) years of successful recent employment experience in the specialty area to be taught.
- Must possess a complete and thorough knowledge of procedures and methods related to teaching.
- Willingness to remain current in the technological changes of the industry.
- Shall possess skills and knowledge in all areas of aesthetics.
- Possess good character, mature attitude, stable personality, and exhibit evidence of potential ability to instruct.
- Possess good organizational, mathematical, language, writing and communication skills.

## **General Duties**

- Develop course of study and conduct training program in specialty area.
- Formulate teaching outline and determine instructional methods utilizing knowledge of specific training needs and effectiveness of such methods as individualized and group instruction, lecture, demonstration, and conference.
- Test trainees to measure progress and evaluate effectiveness of instruction.
- Select or develop specifications for machines, equipment, and tools; maintain good physical conditions in classroom and/or shop.
- Maintain student records and reports.
- Responsible for student placement and assist with student follow-up.
- Cooperate with outside agencies; work with program advisory committees; conduct visits to business and industry; establish and maintain good public relations with the schools general public.
- Participate in recruitment of students.
- Instruct students in safety and practice good safety habits.

<u>Salary:</u> Commensurate with qualifications, experience, education, and in accordance with the guidelines established by the Tennessee Board of Regents.
